

III.



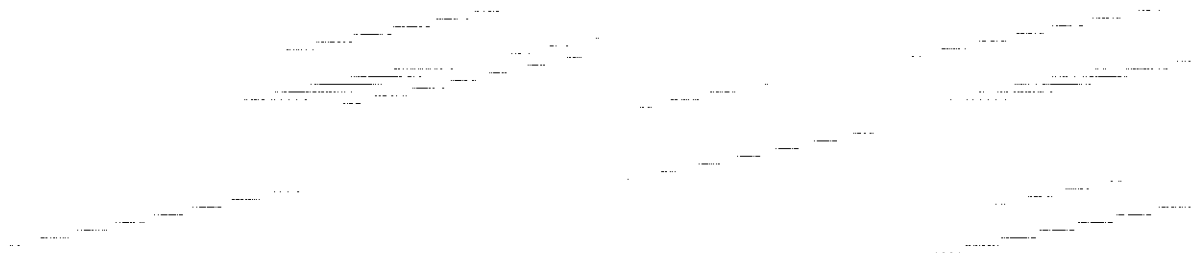
Movant prays that the Court accept his resignation as an Attorney and Counselor at Law and remove his names from the list of persons licensed to practice law in the State of Texas.

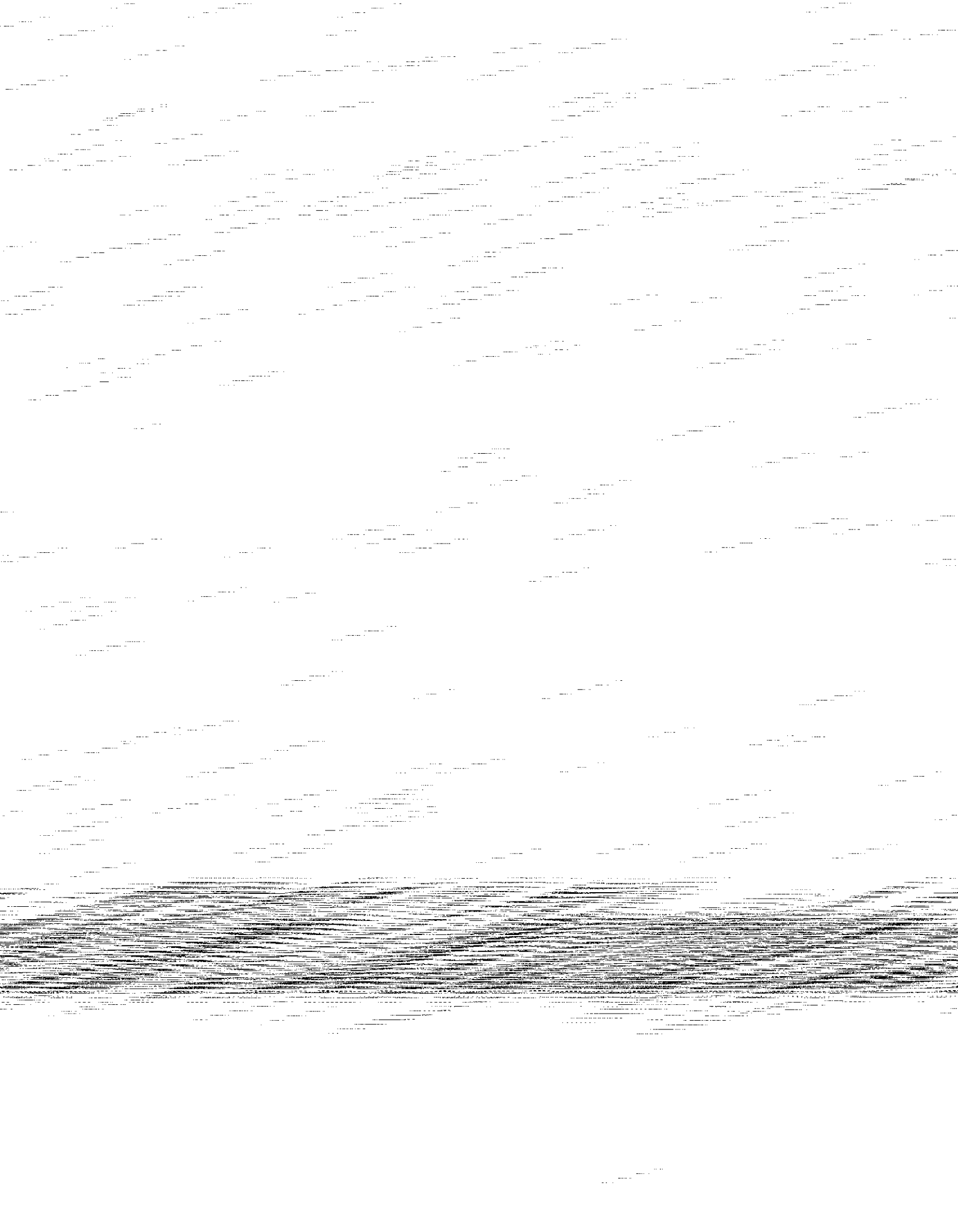
1. The first flight of the staircase descends from the upper floor to the lower floor. It consists of 10 steps, with a total vertical rise of 3.00 meters. The horizontal run of this flight is 4.00 meters.

2. The second flight of the staircase ascends from the lower floor to the upper floor. It also consists of 10 steps, with a total vertical rise of 3.00 meters. The horizontal run of this flight is 4.00 meters.

3. The two flights are connected by a central landing that is 2.00 meters wide. The total width of the staircase is 6.00 meters.

4. The staircase is supported by a central vertical post and two side posts. The posts are spaced 2.00 meters apart.

5. The total length of the staircase is 10.00 meters.
