

DISCIPLINARY PETITION

TO THE HONORABLE JUDGE OF SAID COURT:

Petitioner, the Commission for Lawyer Discipline, a committee of the State Bar of Texas (hereinafter called "Petitioner"), complaining of Respondent, Ronald Galloway, (hereinafter called "Respondent"), showing the Court:

I.

Discovery Control Plan

Pursuant to Rules 190.1 and 190.3, TEXAS RULES OF CIVIL PROCEDURE (TRCP), Petitioner intends discovery in this case to be conducted under the Level II Discovery Control Plan.

II.

Petitioner brings this disciplinary action pursuant to the State Bar Act, Tex. Gov't. Code Ann. §81.001, et seq. (Vernon 1988), the Texas Disciplinary Rules of Professional Conduct and the Texas Rules of Disciplinary Procedure. The complaint which forms the basis of the Disciplinary Petition was filed on or after May 1, 1992.

III.

Respondent is an attorney licensed to practice law in Texas and is a member of the State Bar of Texas. Respondent is a resident of and has his principal place of practice in Dallas County, Texas.

Southwest Security and Investigations will serve citation on Respondent by serving citation on Ronald Stuart Galloway at 13538 Method Street, Suite B, Dallas, Texas 75243.

CAUSE OF ACTION ARISING FROM EMPLOYERS REINSURANCE COMPLAINT

IV.

Respondent represented Pamela Bennett Kabir, the plaintiff in a lawsuit against Employers Reinsurance ("E.R.") styled Bennett v. Employers Reinsurance Corporation, Employers Reassurance Corporation, Robert Cross, Jerry Clark, and Susie Herbel, Civil Action No. 3:97-CV1256-D (consolidated with Civil Action No. 3:98-CV2476-D). During the course of the Bennet lawsuit, Respondent learned of information that he used to make unsolicited phone calls to Sharan Stickrath, E.R.'s current employee, for the purpose of obtaining employment in a possible future lawsuit against E.R.

V.

Such acts and/or omissions on the part of Respondent as are described in Paragraph IV, hereinabove, which occurred on or after January 1, 1990, constitute conduct which violates Rule 7.03(a) of the Texas Disciplinary Rules of Professional Conduct.

VI.

The complaint which forms the basis of the Cause of Action hereinabove set forth was brought to the attention of the Office of the Chief Disciplinary Counsel of the State Bar of Texas by Employers Reinsurance filing a complaint on March 30, 2000.

PRAYER

WHEREFORE, PREMISES CONSIDERED, Petitioner prays for judgment that


Respondent be disciplined as the facts shall warrant; and that Petitioner have such other relief to which entitled, including costs of Court and attorney's fees.


