
ORDER SUSPENDING ATTORNEYS PURSUANT TO  
ARTICLE XII, SECTION 8, STATE BAR RULES




The State Bar of Texas has notified the Court that the attorneys listed in Exhibit 1, attached, are licensed to practice law in Texas, that SEPTEMBER is their Minimum Continuing Legal Education reporting month, and that they failed to comply with the requirements of Article XII, State Bar Rules. IT IS ORDERED this 25<sup>th</sup> day of March, 2002.






