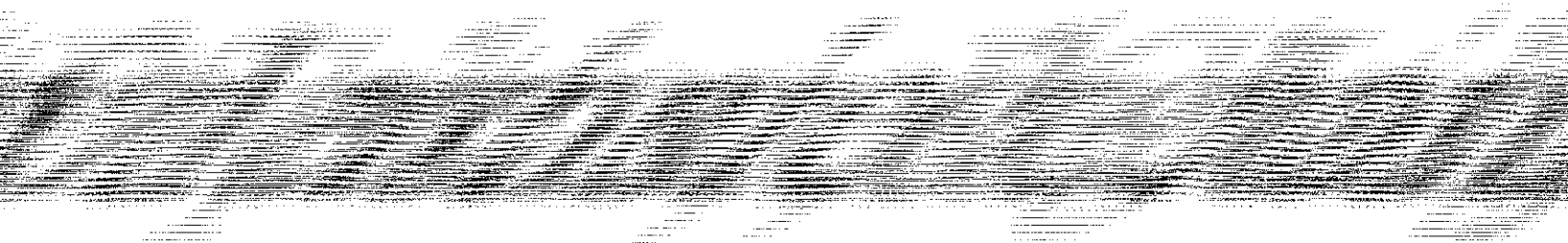

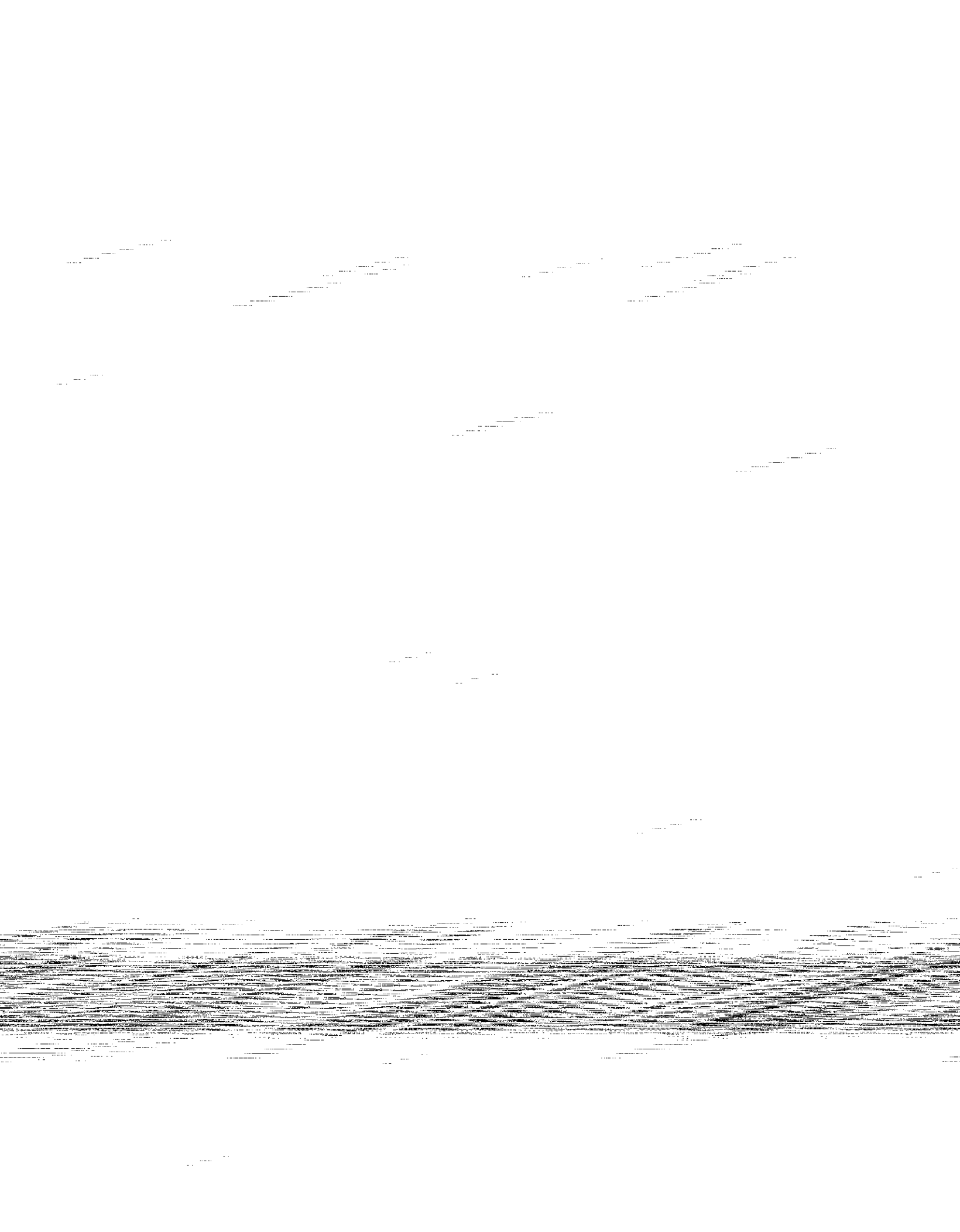

The defendant, JOSE ANTONIO CHAVEZ (aka: Tony), was represented by Gerald H. Goldstein, Cynthia Orr, and Jeffrey Parras.

On motion of the United States, the Court has dismissed Count(s) 1, 2, 3, 4, 5, 6, 7, 34, and 35 of the Superseding Indictment and Count(s) 1, 2, 26, 28, and 35 of the Second Superseding Indictment.

The defendant pled guilty to Count(s) 27 of the Second Superseding Indictment on July 30, 1998. Accordingly, the defendant is adjudged guilty of such Count(s), involving the following offense(s):

It is further ordered that the defendant shall notify the United States Attorney for this district within 30 days of any change of name, residence, or mailing address until all fines, restitution, costs, and special assessments imposed by this Judgment are fully paid.
