SUMMARY OF REPORTED ACTIVITY FOR YEAR ENDED AUGUST 31, 2004

The Alternative Dispute Resolution Centers of Texas were reauthorized and expanded in scope in 1987 by the 70th Legislature "to encourage the peaceable resolution of disputes, with special consideration given to disputes involving the parent-child relationship, and the early settlement of pending litigation through voluntary settlement procedures." (Acts 1987, 70th Legislature, Chapter 1121, Section 1.) Alternative Dispute Resolution Centers provide an opportunity to resolve conflicts creatively and effectively outside the courtroom using a variety of mechanisms including mediation, arbitration, negotiation, and moderated settlement conferences.

Twelve of the 14 centers submitted reports for the period of September 1, 2003 through August 31, 2004. (Note: This summary does not include data from judges, court clerks, private groups, and other organizations that actively employ alternative dispute resolution procedures, but do not formally report associated statistics.)
