15-0232 LEVINSON ALCOSER ASSOCIATES, L.P. AND LEVINSON ASSOCIATES, INC. v. EL PISTOLÓN II, LTD.; from Hidalgo County; 13th Court of Appeals District (13-13-00723-CV, 500 SW3d 431, 02-12-15)

The Court reverses the court of appeals' judgment and remands the case to the trial court.

Justice Devine delivered the opinion of the Court, in which Chief Justice Hecht, Justice Green, Justice Johnson, Justice Willett, Justice Guzman, Justice Lehrmann, and Justice Boyd joined.

Justice Brown delivered a concurring opinion.
