COVID-19 Operating Plan for the Bandera County Judiciary

Recognizing the need to ensure the health and safety of litigants, attorneys, visitors, court staff, judges, and other individuals entering the buildings housing the courts, the courts of

Bandera County will implement the following protective measures:

General

- 1. All judges will comply with the Emergency Orders issued by the Supreme Court of Texas and Court of Criminal Appeals, including conducting in-person proceedings according to the guidance issued by the Office of Court Administration regarding social distancing, maximum group size, and other restrictions and precautions.
- 2. All judges will use all reasonable efforts to conduct proceedings remotely.
- 3. The local administrative district judge will maintain regular communication with the local health authority and county judge and adjust this operating plan as necessary with conditions in the county.
- 4. Judges will begin setting non-essential in-person proceedings no sooner than June 1, 2020

Judge and Court Staff Health

- 1. Judges and court staff who can perform the essential functions of their job remotely will telework when possible.
- 2. Judge and Court Staff Monitoring Requirements: temperature will be taken daily upon arrival, employees will immediately notify a judge if they have exhibited any of the signs or symptoms of covid or have traveled outside of Bandera County.
- 3. Judges or court staff who feel feverish or have measured temperatures equal to or greater, than 100.0 degrees Farenheight, or with new or worsening signs or symptoms of COVID-19 such as cough, shortness of breath or difficulty breathing, chills, repeated shaking with chills, muscle pain, headache, sore throat, loss of taste or smell, diarrhea, or having known close contact with a person who is confirmed to have COVID-19 will not be permitted to enter the building and should seek medical advice.
- 4. Judges and court staff will be required to practice social distancing, and practice appropriate hygiene recommendations at all time. Employees will be required to wear appropriate face covering when dealing with the public or entering a court room.
- 5. Protective Measures: temperatures are taken daily upon arrival, hand sanitizer will be readily available, plexiglass screens are installed for judge and court staff in the court room, gloves are available for all employees handling documents or screening the public, face coverings are available for all staff, social distancing will be enforced, work stations and court rooms will be sanitized regularly.

Scheduling

- 1. The following court schedules are established to reduce occupancy in the court building: Where two or more courts operate with a common foyer, scheduling will be used to minimize the number of people in the common area. Courtroom occupancy limits have been assigned to each court room gallery and said limits will be enforced. Courts will schedule or accommodate vulnerable population individuals to minimize risks of exposure. Persons waiting or loitering in common areas will be encouraged to wait outside. Courts may use signin sheets with contact information to facilitate allowing parties to wait in their vehicles or other areas outside of the court until their case is called.
- 2. District Court will set their out of custody arraignment/pretrial dockets at the Mansfield Hall.

Vulnerable Populations

- Individuals who are over age 65 and individuals with serious underlying health conditions, such as high blood pressure, chronic lung disease, diabetes, obesity, asthma, and those whose immune systems are compromised such as by chemotherapy for cancer or other conditions requiring such therapy are considered to be vulnerable populations.
- 2. Each judge will include information on orders setting hearings, dockets notices, and in other communications notifying individuals who are in vulnerable populations of the ability to contact the court to identify themselves as a vulnerable individual and receive accommodations. A notice with this information will be posted on the courts' websites and in conspicuous locations around the court building (a copy of which is attached).
- 3. Vulnerable populations who are scheduled for court will be accommodated by rescheduling, priority scheduling, zoom and telephonic hearings.

Social Distancing

- 1. All persons not from the same household who are permitted in the court room will be required to maintain adequate social distancing of at least 6 feet.
- 2. Each restroom has been evaluated to determine the appropriate capacity to ensure social distancing and the maximum capacity has been posted on each restroom door.
- 3. Public common areas, including break-rooms and snack-rooms, have been closed to the public.

Gallery

- 4. The maximum number of persons permitted in the gallery of each courtroom has been determined and posted. Gallery occupancy limits will be enforced. The occupancy of the courtroom will be monitored for social distancing and be enforced by court staff.
- 5. The gallery of the courtroom has been marked to identify appropriate social distancing in the seating. Seating is limited to every other row and includes social distancing on rows in use.

Well

- 6. In each courtroom, the counsel tables, witness stand, judge's bench, and clerk, court reporter, and bailiff seating have been arranged in such a way so that there is social distancing of at least 6 feet between each space. Social distancing will be enforced. Social distancing between attorneys and their clients will be enforced.
- 7. Plexiglass guards are installed to protect staff and parties.

<u>Hygiene</u>

- 1. Hand sanitizer dispensers have been placed at the entrances to the court rooms, outside of elevators on each floor, outside of each courtroom, and outside of bathrooms. Hand sanitizer will be located in the well of the court room.
- 2. Tissues have been placed near the door of the courtroom, at counsel tables, at the witness stand, on the judges' benches, and in the hallways.
- 3. A "How to put on and remove a face mask" flyer has been posted in multiple locations on each floor of the court building.
- 4. The Department of State Health Service's "Stop the Spread of Germs Flyer" has been posted in multiple locations on each floor of the court building.

Screening

- 1. When individuals attempt to enter the courtroom, security or court staff will ask the individuals by questionnaire if they are feeling feverish; have a cough, shortness of breath, or difficulty breathing, have been in close contact with a person who is confirmed to have COVID-19, have recently lost sense of smell or taste, or have diarrhea or nausea. Individuals who indicate yes to any of these questions will be refused admittance to the courtroom.
- 2. When individuals attempt to enter the court room, security or court staff will use an infrared thermometer to determine the temperature of the individual. Individuals whose temperature equals or exceeds 100.0°F will be refused admittance to the court building.
- 3. Inmates being transported from the jail to the court building will be screened for symptoms of COVID-19 and have their temperature taken prior to transport. Inmates with symptoms or a temperature equal to or above 100.0°F will not be transported to the court building.
- 4. Staff whom are screening individuals entering the court room will be provided personal protective equipment, including face covering, and gloves.

Face Coverings

- 1. All individuals entering the court room will be required to wear face coverings at all times.
- 2. Individuals will be encouraged to bring cloth face coverings or masks with them, but if the individual does not have a face covering, a disposable face mask will be provided.

Cleaning

- 1. Court building cleaning staff will clean the common areas of the court building so that common spaces are cleaned at least every twelve hours. Court rooms will be cleaned daily.
- 2. Court building cleaning staff or court staff will sanitize the courtrooms between every hearing, between morning and afternoon proceedings, and at the end of each day the courtroom is used.
- 3. Court building cleaning staff have been provided cleaning supplies shown to be effective with this coronavirus.
- 4. Court building cleaning staff have been trained on proper cleaning techniques and provided appropriate personal protective equipment.

Other

- 1. Judges and court staff will wear face masks in the court room except when protected by plexiglass shield.
- 2. Plexiglass shields are installed at the bench and each work station including council tables.
- 3. Markings on the floor demarcate social distancing.
- 4. Benches in gallery are marked to enforce social distancing.

I have conferred with all judges of courts with courtrooms in the court building regarding this Operating Plan. In developing the plan, I consulted with the local health authority, and the local infection prevention person at Peterson Regional Medical Center and the county judge, documentation of which is attached to this plan. I will ensure that the judges of courts with courtrooms in the court building covered by this Operating Plan conduct proceedings consistent with the plan.

POLICY AND PROCEDURES COVID-19

JUSTICE OF THE PEACE, PCT. 1 & 4

BANDERA COUNTY, TEXAS

Recognizing the need to ensure the health and safety of litigants, attorneys, visitors and court staff, judges, and other individual entering the building or housing the court, the Justice Court of Bandera County will implement the following protective measures:

- 1. A plexiglass shield has been installed across the walk-up window to protect clerks when people enter the building to conduct business.
- 2. Court staff will wear a protective mask when dealing with the public at the window.
- 3. The front counter will be wiped clean after each visit by the public at the window.
- 4. Court staff and judges will use hand sanitizers periodically during the day.

No in-person hearings unless a hearing is deemed essential proceeding as published by OCA until June 1st, 2020.

After June 1^{st} , 2020, the court staff and judges will continue to follow the above procedures and additional protective practices:

- 1. The court will begin to issue civil citations. The court will begin to hear civil and criminal bench trials and all other hearings.
- 2. The courtroom will be limited to 6 persons including the judge. All persons will be screened prior to entering the courtroom and answer the screening questions attached to this policy. All persons in the courtroom will wear masks.
- 3. The courtroom will be wiped clean after each proceeding.
- 4. Criminal hearing will be held in the courtroom.
- 5. Monthly pretrial hearing will be held under the direction of the judge for that month and will be subject to guidelines issued by the court with the consultation of the prosecuting attorney.
- 6. Vulnerable Persons Notice will be posted in the lobby of the court. All pretrial notices will include the Vulnerable Population Notice.
- 7. The judge will give special priority to vulnerable persons with setting dockets, hearing and bench trials.
- 8. In all cases the court staff and judges should encourage persons coming to the court to practice social distancing and good hygiene.
- 9. All guidelines issued by OCA and the administrative district judge will be followed at all times.
- 10. Any court staff that sees a situation that is unsafe or unsanitary will notify the judge immediately.

In the interest of safety to all in regards to Covid-19 and mandated by the Office of Court Administration, the following protective measures will be implemented:

Occupancy of the entry/lobby will be restricted to one (1) person at the Tax Office and one (1) person at the JP clerk window unless there is a necessary reason for a family member to be in attendance.

A clear plastic sheet will be installed at chief clerk's window to limit public exposure.

Sanitizer & tissues will be readily accessible throughout the courthouse.

A social distance of six (6) feet must be maintained throughout the courthouse.

Maximum Occupancy of the restroom is limited to two (2).

Maximum Occupancy of the courtroom is limited ten (10).

All persons entering the courtroom will be screened with a written questionnaire and have their temperature taken. No one with symptoms or temperature of 100.0 degrees or above will be able to enter the courtroom and must leave the building immediately.

Vulnerable Persons will be sent notification in every written communication from our office.

Vulnerable Persons will be given preference in all functions of the court to limit their time in our court building.

The tables, chairs and doorknobs will be wiped between court proceedings.

All meetings wil be held electronically or in courtroom to maintain social distancing.

Face masks will be required in the courtroom.

All guidelines issued by the OCA and administrative district judge will be followed at all times.

HOW TO PUT ON A FACE MASK

- CLEAN YOUR HANDS WITH SOAP AND WATER OR HAND SANITIZER BEFORE TOUCHING MASK.
- 2. REMOVE A MASK FROM THE BOX AND MAKE SURE THERE AER NO OBVIOUS TEARS OR HOLES IN EITHER SIDE OF THE MASK.
- 3. DETERMINE WHICH SIDE OF THE MASK IS THE TOP. THE SIDE OF THE MASK THAT HAS A STIFF BENDABLE EDGE IS THE TOPE AND IS MEANT TO MOLD TO THE SHAPE OF YOUR NOSE.
- 4. DETERMINE WHICH SIDE OF THE MASK IS THE FRONT, THE COLORED SIDE OF THE MASK IS USUALLY THE FRONT AND SHOULD FACE AWAY FROM YOU, WHICH THE WHITE SIDE TOUCHES YOUR FACE.
- 5. FOLLOW THE INSTRUCTIONS BELOW FOR THE TYPE OF MASK YOU ARE USING:
 - a. Face Mask with Ear Loops: Hold the mask by the earl loops. Place a loop around each ear.
 - b. Face Mask with Ties: bring the mask to your nose level and place the ties over the crown of your head and secure with a bow.
 - c. Face Mask with Bands: hold the mask in your hand with the nosepiece or top of the mask at fingertips, allowing the headbands to hang freely below hands. Bring the mask to your nose level and pull the top strap over your head so that it rests over the crown of your head. Pull the bottom strap over your head so that it rests at the nape of your neck.
- 6. MOLD OR PINCH THE STIFF ENDS TO THE SHAPE OF YOUR NOSE.
- 7. IF USING A FACE MASK WITH TIES: THEN TAKE THE BOTTOM TIES, ONE IN EACH HAND, AND SECURE WITH A BOW AT THE NAPE OF YOUR NECK.
- 8. PULL THE BOTTOM OF THE MASK OVER YOUR MOUTH AND CHIN.

HOW TO REMOVE A FACE MASK

- CLEAN YOUR HANDS WITH SOAP AND WATER OR HAND SANITIZER BEFORE TOUCHIGN THE MASK. AVOID TOUCHIGN THE FRONT OF THE MASK. THE FRONT OF THE MASK IS CONTAMINATED. ONLY TOUCH THE EAR LOOPS/TIES/BAND. FOLLOW THE INSTRUCTIONS BELOW FOR THE TYPE OF MASK YOU ARE USING.
 - a. Face Mask with Ear Loops: Hold both of the ear loops and gently lift and remove the mask.
 - b. Face Mask with Ties: Until the bottom bow first then until the top bow and pull the mask away from you as the ties are loosened.
 - c. Face Mask with Bands: Lift the bottom strap over your head first then pull the top strap over your head.
- 2. THROW THE MASK IN THE TRASH. CLEAN YOUR HANDS WITH SOAP AND WATER OR HAND SANITIZER.
