# 18-1223 TEXAS BOARD OF CHIROPRACTIC EXAMINERS; PATRICK FORTNER, IN HIS OFFICIAL CAPACITY AS THE BOARD'S EXECUTIVE DIRECTOR; AND TEXAS CHIROPRACTIC ASSOCIATION v. TEXAS MEDICAL ASSOCIATION; from Travis County; 3rd Court of Appeals District (03-17-00037-CV, 566 SW3d 776, 11-21-18) 2 petitions

The Court reverses the court of appeals' judgment in part and renders judgment.

Chief Justice Hecht delivered the opinion of the Court, in which Justice Guzman, Justice Lehrmann, Justice Devine, Justice Blacklock, and Justice Busby joined in full, and in which Justice Boyd and Justice Bland joined except with respect to Part III(D).

Justice Bland delivered an opinion dissenting in part, in which Justice Boyd joined. (Justice Huddle not participating)

19-0533 PATIENTS MEDICAL CENTER v. FACILITY INSURANCE CORPORATION; from Travis County; 3rd Court of Appeals District (03-17-00666-CV, 574 SW3d 436, 12-05-18)

The Court reverses the court of appeals' judgment and remands the case to that court.

Justice Lehrmann delivered the opinion of the Court.
