19-0459 BLUESTONE NATURAL RESOURCES II, LLC v. WALKER MURRAY RANDLE, ET AL.; from Hood County; 2nd Court of Appeals District (02-18-00271-CV, 601 SW3d 848, 04-18-19)

The Court affirms in part and reverses in part the court of appeals' judgment and remands the case to the trial court.
