RITA PORTER, INDIVIDUALLY & AS MOTHER & NEXT FRIEND OF DAWONE PORTER, A MINOR CHILD; AMANDA GUTIERREZ, INDIVIDUALLY; ARMANDO AND YVONNE GUTIERREZ, INDIVIDUALLY AND AS PARENTS AND NEXT FRIENDS OF ARMANDO, A MINOR CHILD; PATTY GORDON; AND DYLON GORDON; from El Paso County; 8th Court of Appeals District (08-13-00002-CV, 569 SW3d 686, 10-31-18)

The Court affirms in part and reverses in part the court of appeals' judgment and renders judgment.

The Court reverses the court of appeals' judgment and remands the case to the trial court.

Justice Boyd delivered the opinion of the Court. (Justice Guzman not participating)

The Court conditionally grants the writ of mandamus.

Justice Huddle delivered the opinion of the Court.

The Court denies the petition for writ of mandamus.

Justice Bland delivered a dissenting opinion, in which Justice Lehrmann joined.

The Court denies the petition for writ of mandamus.

Justice Bland delivered the opinion of the Court, in which Chief Justice Hecht, Justice Guzman, Justice Lehrmann, Justice Boyd, Justice Devine, Justice Busby, and Justice Huddle joined, and in which Justice Blacklock joined except as to Part III.B.

Justice Blacklock delivered a concurring opinion.

20-0368 JLB BUILDERS, L.L.C. v. JOSE HERNANDEZ; from Dallas County; 5th Court of Appeals District (05-17-00719-CV, 600 SW3d 485, 03-26-20)

The Court reverses the court of appeals' judgment and renders judgment.

Justice Lehrmann delivered the opinion of the Court.


