JUDICIAL BRANCH CERTIFICATION COMMISSION MINUTES OF THE MEETING

The meeting of the Judicial Branch Certification Commission (JBCC or Commission) was called to order by Judge William Sowder, Vice Chair, at 10:02 a.m., Friday, November 5, 2021. Members in attendance were Judge William Sowder; Judge Polly Spencer; Judge Victor Villarreal; Judge Glen Harrison; Velma Arellano; Don Ford; Ann Murray Moore; and Mark Blenden. Judge Sid Harle was not in attendance.

Agenda Item III. Opening Remarks

Judge Sowder welcomed everyone to the meeting, noting he was presiding over this meeting on Judge Harle's behalf.

Jeff Rinard, EPRS director, gave an update on performance measures for Fiscal Year 2022. This year, staff processed 1017 new certifications, 1865 renewal applications, 5954 guardianship registrations, 6567 criminal history checks. 6283 guardianship online trainings were taken this year. Staff also administered 299 written exams for guardians and court interpreters, investigated 118 complaints, and staffed commission meetings and advisory board meetings. Mr. Rinard thanked JBCC staff for their hard work during the fiscal year.

Agenda Item IX. Administrative Matters Relating to the JBCC Jeff Rinard, EPRS Director, gave an update on the following agenda items:

- A. Proposed JBCC Rules Update During the August 6, 2021 Commission meeting, the Commission adopted the following proposed rules:
 - Code of Ethics and Minimum Standards Section 21(c) This changes the reporting requirement to JBCC director on maximum number of wards assigned to them from 50 to 40.
 - JBCC Rule 7.2(b) Requirement for Obtaining Guardian Certification – This change adds a new option for fulfilling educational prerequisites.
 - Add "Guardianship Program" to Code of Ethics and Minimum Standards.
 - Expanding the court reporter definition to include apprentice and provisional court reporters.
 - Adding FBI background check as a requirement for out of state guardians registering with the JBCC.
 - Rules for 24-hour guardianship mediation training course.
 All proposed rules were adopted by Supreme Court on August 27, 2021 and are effective September 1, 2021.
- B. Update on Court Reporter Reciprocity Outreach
 The JBCC has been working with the court reporter associations and
 other stakeholders over the past few years to address the court
 reporter shortage. During the legislative session 2 years ago, the
 JBCC was told to reach out to other states and attempt to establish
 reciprocity agreements. The JBCC has been working with the state of
 California to reach an agreement. However, California recently stated
 they were not going to participate in reciprocity with Texas. California
 has an endorsement process that court reporters can use if they move
 to Texas. One of the reasons they gave is that California was not able
 to properly review Texas examination. California is open for future

reciprocity, but they are not interested at this time. The JBCC has reached out to 31 states, and currently 5 states are interested: Iowa, New Mexico, New Jersey, Mississippi, and Oklahoma.

- C. Update on JBCC Examinations
 - LCI and Guardian Online Written Exams
 Licensing Manager Sheryl Jones is working with BlackBoard to
 have these exams online, and the online format is expected to
 be implemented after the new year. Benefits of having the
 exams online include examinees not having to travel to Austin,
 JBCC does not have to staff the exam, and examinees get an
 automatic score.
 - LCI Oral Exam Administered in El Paso, Texas
 This matter was not addressed at this meeting and will be discussed at the February 4, 2022 meeting.
- D. Update on Guardianship Program and Guardianship Registrations The program works with the courts to ensure guardianships are monitored throughout the state. Staff has reviewed almost 60,000 guardianship files around the state. When staff goes out, they always review more files than anticipated once they are out at the county, as courts and clerks don't always have everything completely tracked. 153 counties and 200 courts have been reviewed. Once reviewed, staff sends a report back with the judge, and Mr. Rinard feels that has been very effective with compliance and helping the courts clean up their dockets. Staff has also done financial audits for the counties. Mr. Rinard also noted that the National Center for State Courts has reached out to the JBCC. Several states are participating in a grant with the NCSC, and they would like to model the JBCC's guardian program.
