**II. Meeting Minutes from the Previous Meeting**

**Motion** to approve the minutes from the June 2023 meeting by **Bob Wessels**, seconded by **John Warren**. No opposition. **Motion carried.**

**III. Program Updates**

**A. eFileTexas/re:SearchTX/Guide and File**

Evan Acosta with Tyler Technologies presented an update on the system. Mr. Acosta reported the filing levels are level at 43k per day. He mentioned that of the top 20 counties in the state, all but two have a JP court on eFile.

Mr. Acosta then reported on the return for correction rate for the state, which is trending lower than the national average. He reported that the top three return for correction reasons are steady at Filer's Request (1), Incorrect Formatting (2), and Judge's request (3). Mr. Acosta spoke about the Judge's request returns being partially from jurisdictions that run their proposed order processes in the eFiling system instead of their local CMS.

Mr. Acosta revisited a request from the previous meeting on sensitive data in filings and enumerated the top case types containing sensitive data as requested. Justice Boyd asked about the status of the changes JCIT discussed to the user interface to prevent the

improper marking of sensitive data on documents filed. Terry Derrick with Tyler Technologies reported that it is being worked on and would come to the next meeting with an update.

He also reviewed the current project roadmap with upcoming features and their timelines for deployment.

#### **IV. Committee Updates**

##### **A. Standards**

Mr. Wessels updated the committee that the Supreme Court and Court of Criminal Appeals updated the Technology Standards to include language on the timeliness by clerks to accept/return/reject electronic filings.

#### **V. New Business**

##### **A. Discussion of Supreme Court Administrative Order 23-9053 Delivery of Court Orders, Notices, and Other Documents Through the E-filing System**

Justice Simmons reviewed the charges to JCIT and asked that a subcommittee be set to talk about getting orders in to re:SearchTX in order to get the orders out. The group talked about CMS vendors integrating with re:SearchTX and the ability to do it along with security concerns.

Justice Simmons asked that the subcommittee explore the issues with integration along with reviewing the security matrix as well.

Ms. Price and Ms. Hopper relayed the need to clarify on the specific types of notices that are applicable to the order as well.

Justice Simmons set the subcommittee and asked that they meet weekly to progress through the charge and to present recommendations at the next meeting.

##### **B. Discussion of proposed revision to TRCP 3a to protect against courts issuing local rules that set different standards or requirements for e-filing**

Judge Hinde was not present, and Justice Simmons asked that this item be postponed until the next meeting.

##### **C. Discussion of AI bots in use in Tarrant County**

Terry Derrick from Tyler Technologies spoke about the process in use in Tarrant County with bots that review and accept electronic filings. Mary Louise Nicholson from Tarrant County mentioned that they had to shut off their bots on the weekends since they were working too fast for the upstream humans.

Mr. Kennedy mentioned that OCA is working with Tyler Technologies to see if and how it could expand to a statewide model. Justice Simmons ask that Tyler Technologies give a demo at the next meeting.

**A. Next steps to include criminal eFilings in re:SearchTX**

Sian Schilhab reported that JCIT recommendations are currently under consideration by the Court of Criminal Appeals
