Jeff Rinard, Commission director, thanked the Commission for their service and the staff for their hard work. Mr. Rinard noted that there are two new staff members, Annette Arevalo and Matt Sanford, and the JBCC is fully staffed. Since the last meeting, there have been several complaint review committees, and 26 candidates took the guardianship exam, LCI exam coming up. Working with Judicial Council and Megan Lavoie, Administrative Director for the Texas Office of Court Administration, to address court reporter shortage, also working with associations. There has been a 22% drop in court reporters since 2005, and an increase in the number of courts. There is a shortage especially in the rural areas.
