MINUTES OF PREVIOUS MEETING

The February 8, 2024, meeting minutes were approved as presented.

REPORTS AND ACTION ITEMS

Civil Justice Committee Update – Justice Emily Miskel

Justice Emily Miskel, Chair of the Civil Justice Committee, gave an update on current work of the Committee. The Committee has seven charges and reviewed three during the first meeting on April 1st. Justice Miskel updated on the progress of the Texas Business Court, the use of Artificial Intelligence in Texas courts, and monitoring the legislative mandated study on the court personnel workload of the district and statutory county courts.

Public Trust and Confidence Committee Update – Judge Ed Spillane

Judge Ed Spillane, Chair of the Public Trust and Confidence Committee, gave an update on the work of the committee. The Committee has eight charges and looked at four during the first meeting on April 17th. The Committee reviewed the legislative mandated study on court personnel workload, reviewed the comprehensive all-hazard emergency management plans for the judiciary, reviewed judicial profession shortages, and is studying ways to expand, improve, and strengthen the Centers for Excellence.

Criminal Justice Committee Update – Judge Missy Medary

Judge Missy Medary, Chair of the Criminal Justice Committee, gave an update on the work of the committee. The Committee has seven charges and reviewed four during the first meeting on April 3rd. The Committee reviewed studying ways to improve court and personal security for judges and court staff, the evaluation and monitoring of Texas' pretrial bail system for improvement, the judiciary's role and work on Operation Lone Star, and the legislative mandated study on court personnel workload.

Data Committee Update – Judge Bill Gravell

Judge Bill Gravell, Chair of the Data Committee, gave an update on the work of the committee. The committee has five charges and reviewed three of them during the first meeting on April 16th. The Committee reviewed the court activity reporting requirements to collect case-level statistical data and guiding revisions, the use of Artificial Intelligence in Texas Courts, and ways to strengthen communication plans covering the importance of judicial data collection and positive impacts data transparency has on the judiciary and policy.

Texas Indigent Defense Commission Report – Scott Ehlers

Scott Ehlers, Executive Director, Texas Indigent Defense Commission, gave an update on the Commission's current work, accomplishments, and reviewed the Commission's report.

Report on Centers of Excellence and Consideration of Approval of Designation – Michael Smith Michael Smith, Management Analyst, Office of Court Administration, gave a review of the Nomination Report on Travis County Justice of the Peace, Precinct 3 and asked the Council for Consideration and Approval of the Designation as a Center of Excellence.

A motion was made to approve designation as a Center of Excellence to the Travis County Justice of the Peace Precinct 3. The designation was approved unanimously.
