**ORDER ON DEFENDANTS' MOTION TO DECLARE
PLAINTIFF ERICKA MOON A VEXATIOUS LITIGANT**

ON THIS DAY, came to be heard Defendants Mary Zoe Collier, Individually, and Dr. Mary Zoe Collier, DDS, PLLC d/b/a Smile McKinney Dental's *Motion to Declare Plaintiff Ericka Moon a Vexatious Litigant*. After considering the Motion, pleadings, arguments of the parties, and evidence, if any, the Court is of the opinion that the Motion is well taken and should be **GRANTED**.

IT IS THEREFORE ORDERED, ADJUDGED, and DECREED:

1. Ericka Moon a/k/a Ericka Denise Frank James a/k/a Cassandra Frank a/k/a Denise Frank a/k/a Erica Frank a/k/a Candy Franks a/k/a Erica Denise Franks a/k/a Ericka Denise Moon is declared a vexatious litigant under Section 11.054(2) of the Texas Civil Practice and Remedies Code.
2. Plaintiff Ericka Moon must furnish security in the amount of \$2,500 by December 19, 2025. The Court states that the security is an undertaking by Plaintiff, Ericka Moon, to assure payment to Defendants for their reasonable expenses incurred in this matter, including costs and attorney fees, should this case be dismissed on the merits.
3. If Plaintiff does not furnish the required security within the time limit set by this Order, the Court will dismiss all of Plaintiff's claims against Defendants with prejudice.
4. Plaintiff's claims in this matter are abated until ten (10) days after Plaintiff complies with this Order and Defendants are provided with written notice that Plaintiff has furnished the

required security, or until Plaintiff's claims are dismissed by further order of this Court. *See* TEX. CIV. PRAC. & REM. CODE § 11.052.

5. Plaintiff Ericka Moon is hereby declared a vexatious litigant under Section 11.101 of the Texas Civil Practices and Remedies Code. Therefore, Ericka Moon is hereby prohibited from filing pro se any new litigation in any court within the State of Texas without the consent and permission of the appropriate local administrative judge.

IT IS FURTHER ORDERED that the Clerk shall provide a copy of this Order to the Office of Court Administration of the Texas Judicial Branch.
