**ORDER DECLARING CHARLES JEFF JAYROE A VEXATIOUS LITIGANT
AND ISSUING PREFILING ORDER AGAINST CHARLES JEFF JAYROE**

The Court having considered Defendant Amy Munger's MOTION FOR SANCTIONS AND FOR ORDER DETERMINING CHARLES JEFF JAYROE A VEXATIOUS LITIGANT, and considering the evidence, is of the opinion and finds that Charles Jeff Jayroe is a Vexatious Litigant and a Prefiling Order should be issued against him.

The Court hereby finds the following in support of its ORDER DECLARING CHARLES JEFF JAYROE A VEXATIOUS LITIGANT AND ISSUING A PREFILING ORDER AGAINST CHARLES JEFF JAYROE:

- (1) This case is a "litigation" and Charles Jeff Jayroe is a "plaintiff" for purposes of the Vexatious Litigant Statute, TEXAS CIVIL PRACTICE & REMEDIES CODE Chapter 11, et. seq.;
- (2) The Court finds there is not a reasonable probability that Plaintiff Charles Jeff Jayroe will prevail in the instant litigation;
- (3) The MOTION FOR SANCTIONS AND FOR ORDER DETERMINING CHARLES JEFF JAYROE A VEXATIOUS LITIGANT was filed on October 9, 2025, and thus, the operative Seven (7) year time period for any pro se litigations "commenced, prosecuted, or maintained" by Charles Jeff Jayroe is a time period beginning on October 9, 2018. Litigation filed before then yet still prosecuted or maintained [i.e., on appeal] afterwards counts for the Court's quantifying the number of pro se litigations during the operative time period;
- (4) The Court finds that Charles Jeff Jayroe has commenced, prosecuted or maintained Fifteen (15) pro se litigations in the relevant time period of October 9, 2018, to October 9, 2025, and which have been determined adversely to him. Attached to the APPENDIX TO MOTION FOR SANCTIONS AND FOR ORDER DETERMINING CHARLES J. JAYROE A VEXATIOUS LITIGANT as Exhibit No. 's 1-15, are the corresponding docketsheets and other information for each such litigation which Charles Jeff Jayroe has commenced, prosecuted or maintained since October 9, 2018, and that have been determined adversely to him, which this Court takes judicial notice of for all purposes and has entered into evidence in this case;

- (5) The Court further finds that Charles Jeff Jayroe, after litigation has been finally determined against him, repeatedly relitigates or attempts to relitigate, pro se, either (1) the validity of the determination against the same defendants as to whom the litigation was finally determined; (2) or the cause of action, claim, controversy, or any of the issues of fact or law determined or concluded by the final determination against the same defendants as to whom the litigation was finally determined.
- (6) The Court expressly finds that Charles Jeff Jayroe meets the criteria for being determined to be a Vexatious Litigant under TEX. CIV. PRAC. & REM. CODE §11.054(1)(A) and §11.054(2) and that Charles Jeff Jayroe agrees to same and the entry of this ORDER DECLARING CHARLES JEFF JAYROE A VEXATIOUS LITIGANT AND ISSUING A PREFILING ORDER AGAINST CHARLES JEFF JAYROE; and
- (7) The Court expressly finds that a PreFiling Order, pursuant to TEX. CIV. PRAC. & REM. CODE §11.101(a) and §11.102(a), should be issued against Charles Jeff Jayroe prohibiting him from filing, pro se, any new litigation in a court to which this PreFiling Order applies without first obtaining written permission from the local administrative judge as ordered below.


IT IS, THEREFORE, ORDERED, ADJUDGED AND DECREED that **CHARLES JEFF JAYROE** be and hereby is declared a **VEXATIOUS LITIGANT** pursuant to Chapter 11 of the TEXAS CIVIL PRACTICE AND REMEDIES CODE.

IT IS FURTHER ORDERED that a **PRE-FILING ORDER** be and hereby is issued against **CHARLES JEFF JAYROE** and/or any other name or designation which he may go by, and he is hereby prohibited from filing, pro se, any new litigation of any kind or nature in any state or federal court located in the State of Texas until and unless written permission has first been granted by the appropriate local Administrative Judge, strictly in accordance with and as expressly authorized by TEX. CIV. PRAC. & REM. CODE §11.102.

IT IS FURTHER ORDERED that the District Clerk of Collin County, Texas, as required by TEX. CIV. PRAC. & REM. CODE §11.104(a), shall provide the Office of Court Administration of the Texas Judicial System a copy of this ORDER DECLARING CHARLES JEFF JAYROE A VEXATIOUS LITIGANT AND ISSUING A PREFILING ORDER AGAINST CHARLES JEFF JAYROE not later than the 30th day after the date this ORDER is signed and entered.

CHARLES JEFF JAYROE is further advised that, pursuant to TEX. CIV. PRAC. & REM. CODE §11.101(b), a person who disobeys a Prefiling Order is subject to Contempt of Court.
