- A Appeal of a Parking or Pedestrian Offense committed in a School Zone¹
- B Appeal of a Parking or Pedestrian Offense committed <u>outside a School Zone¹</u>
- C Appeal of conviction for Failure to Secure Child in Safety Seat System² that is committed in a school crossing zone¹
- D Appeal of conviction for Failure to Secure Child in Safety Seat System² that is <u>not</u> committed in a school crossing zone¹
- Appeal of a Class C Misdemeanor Rules-of-the-Road Offense³ other than a Parking or Pedestrian Offense or the offense of Failure to Secure Child in Safety Seat System² that:
 (1) is committed in a school crossing zone¹: and (2) is a moving violation⁴
- F Appeal of a Class C Misdemeanor Rules-of-the-Road Offense³ other than a Parking or Pedestrian Offense or the offense of Failure to Secure Child in Safety Seat System² that:
